

Cervical Pillow

Description

A cervical pillow is a pillow that is used as a neck support. Cervical pillows are not reasonable and necessary in the treatment of disease or injury.

Policy

A cervical pillow is considered not reasonable and necessary as it is not primarily medical in nature.

HCPCS Level II Codes and Description

E0190 Positioning cushion/pillow/wedge, any shape or size

Important Note:

The clinical criteria and medical policies provide guidelines for determining the medical necessity for specific DMEPOS products or services. In all cases, final benefit determinations are based on the applicable contract language. To the extent there are any conflicts between medical policy guidelines and applicable contract language, the contract language prevails. Medical policy is not intended to override the policy that defines the member's benefits, nor is it intended to dictate to providers how to direct care. Northwood Medical policies shall not be interpreted to limit the benefits afforded to Medicare or Medicaid members by law and regulation and Northwood will use the applicable state requirements to determine required quantity limit guidelines.
