# Dehumidifier/Humidifier

### **Description**

A dehumidifier removes moisture from the air. A humidifier adds moisture to the air.

## **Policy**

Dehumidifiers (all types)/humidifiers (house and room) used other than with oxygen systems, ventilators and positive airway pressure devices (CPAP, BiPAP) are considered not reasonable and necessary as they are environmental control equipment and not primarily medical in nature.

Refer to medical policies on oxygen, and positive airway pressure devices (CPAP, BiPAP).

### **HCPCS Level II Codes and Description**

E1399 Durable medical equipment, miscellaneous

#### **Important Note:**

Northwood's Medical Policies are developed to assist Northwood in administering plan benefits and determining whether a particular DMEPOS product or service is reasonable and necessary. Equipment that is used primarily and customarily for a non-medical purpose is not considered durable medical equipment.

Coverage determinations are made on a case-by-case basis and are subject to all of the terms, conditions, limitations, and exclusions of the member's contract including medical necessity requirements.

The conclusion that a DMEPOS product or service is reasonable and necessary does not constitute coverage. The member's contract defines which DMEPOS product or service is covered, excluded or limited. The policies provide for clearly written, reasonable and current criteria that have been approved by Northwood's Medical Director.

The clinical criteria and medical policies provide guidelines for determining the medical necessity for specific DMEPOS products or services. In all cases, final benefit determinations are based on the applicable contract language. To the extent there are any conflicts between medical policy guidelines and applicable contract language, the contract language prevails. Medical policy is not intended to override the policy that defines the member's benefits, nor is it intended to dictate to providers how to direct care.
